ORDER APPOINTING A RECEIVER

(Section 243 of the *Bankruptcy and Insolvency Act*, R.S.C., 1985, c. B-3)

ON READING the *Motion for the Issuance of an Order Appointing a Receiver* (the “**Motion**”) dated April 30, 2026, filed by the Fédération des Caisses Desjardins du Québec (the “**Petitioner**”) as lender and as administrative agent for the lending syndicate formed by Bank of Montreal, Bank of Nova Scotia, National Bank of Canada, The Toronto-Dominion Bank and other lenders (collectively, and including the Petitioner, the “**Lenders**”), filed pursuant to Section 243 of the *Bankruptcy and Insolvency Act*, R.S.C., 1985, c. B-3 (the “**BIA**”), and of the exhibits and the sworn declaration filed in support thereof;

CONSIDERING the testimony of Mr. Claudio Filippone, CPA, CIRP, LIT, of PricewaterhouseCoopers Inc., and the Proposed Receiver’s report dated April 30, 2026;

CONSIDERING the service of the Motion on the Debtors, Revenu Québec, the Canada Revenue Agency, the secured creditors likely affected by the charges sought by the Motion, being Biesse Canada Inc., Investissement Québec, Ville de Lac-Mégantic, Usherwood Business Equipment Inc. d/b/a Usherwood Office Technology and Greatamerica Financial Services Corporation, and the material unsecured creditors Fonds de Solidarité des Travailleurs F.T.Q. and Capital Régional et Coopératif Desjardins;

CONSIDERING the submissions of the Petitioner’s counsel and the testimony of the representative of the Receiver;

CONSIDERING the provisions of the BIA;

CONSIDERING that it is just and appropriate to appoint PricewaterhouseCoopers Inc. (Mr. Claudio Filippone, CPA, CIRP, LIT) to act as receiver to the Debtors’ Property (as defined below), with all the powers granted herein and that PricewaterhouseCoopers Inc. accepts the appointment as receiver in this matter;

CONSIDERING that it is appropriate to approve the Receivership Charges (as defined herein);

CONSIDERING that the powers sought in the Motion are necessary for the preservation of the Debtors’ Property (as defined below) and the preservation of the rights of all creditors;

WHEREFORE THE COURT:

[1] **GRANTS** the Motion;

Service

[2] **ORDERS** that any prior delay for the presentation of this Motion is hereby abridged and validated so that this Motion is properly returnable today and hereby dispenses with further service thereof.

[3] **AUTHORIZES** the service of this order (the “**Order**”) at any time and place and by any means whatsoever, including by email.

Administrative Consolidation

[4] **ORDERS** the consolidation of the present proceedings under one single Court file, in file number 480-11-000189-267.

[5] **ORDERS** that all existing and future proceedings, filings, and other matters (**including**, without limitation, all applications, reports and cash flows) in the present proceedings henceforth be filed under file number 480-11-000189-267.

[6] **DECLARES** that the consolidation of the present proceedings in respect of the **Debtors** shall be for administrative and procedural purposes only and shall not affect a consolidation of the assets and property or of the debts and obligations of each of the Debtors.

Appointment

[7] **APPOINTS** PricewaterhouseCoopers Inc. (Mr. Claudio Filippone, CPA, CIRP, LIT) to act as receiver (the “**Receiver**”) to all assets, undertakings and properties of the Debtors, of every nature and kind whatsoever, wherever situated, and regardless of whose possession it may be in (collectively, the “**Property**”) until the first occurrence of the following events:

- (a) the sale of all of the Property; or
- (b) the issuance of any order rendered by the Court terminating the mandate of the Receiver.

[8] **DECLARES** that this Order and its effects shall survive the filing by the Debtors of a notice of intention to make a proposal or of a proposal pursuant to the terms of the BIA, the issuance of an initial order in respect of the Debtors pursuant to the terms of the *Companies Creditors Arrangements Act*, R.C.S., 1985, c. C-36 or the bankruptcy of the Debtors, unless the Court orders otherwise.

Powers of the Receiver

[9] **AUTHORIZES** the Receiver, without having the obligation to do so, to exercise the following powers, subject to the terms of this Order:

- (a) all powers necessary to take possession, preserve, protect or control the Debtors' Property and to exercise the following powers listed in this Order in the place and stead of the Debtors in respect of the Property;
- (b) all the powers necessary to grant the Receiver access, at all times, to the Debtors' immovable or real property assets, places of business and premises occupied by the Debtors, and to change the locks granting access to such immovable or real property assets, premises and places of business;
- (c) all the powers necessary to grant the Receiver access, at all times, to all the books and records of the Debtors, including the accounting records, as well as to any document, contract and register of any nature or kind whatsoever, wherever they may be situated and regardless of the medium on which they may be recorded (the "**Records**"), as well as the powers necessary to make copies of all the Records necessary or useful to the execution of the Receiver's functions;
- (d) all the powers necessary to undertake an analysis of the Debtors' Records;
- (e) all the powers necessary to continue, control and conduct, in whole or in part, the business, the operations and the activities of the Debtors as well as the wind down and the liquidation of the Property (the "**Business**"), as deemed appropriate and necessary by the Receiver;
- (f) all the powers necessary to (i) negotiate, enter into, approve and execute any liquidation or real estate services agreement and to retain third party consultants, for and on behalf of the Debtors, in such manner as the Receiver, in its sole discretion deems necessary or appropriate, but with the consent of the Petitioner, and (ii) pay all fees and reimbursement of expenses under the aforementioned agreements without further order of the Court;
- (g) all the powers necessary to market, sell, or negotiate the sale of, any or all of the Property;
- (h) all the powers necessary to carry out workforce reductions, including to conduct terminations or layoffs of the Debtors' employees in such manner as the Receiver, in its sole discretion, deems necessary or appropriate, and in all cases notwithstanding the provisions of any applicable collective bargaining agreement;
- (i) all the powers necessary to operate and control (or mandate any professional to do so), for and on behalf of the Debtors, all existing accounts of the Debtors maintained at any financial institution (individually, an "**Account**" and collectively, the "**Accounts**") in such manner as the Receiver, in its sole discretion, deems necessary or appropriate, including, without limitation:
 - i. all the powers necessary to collect all the accounts receivable and all the other claims of the Debtors and to transact in respect of same, including proceeds

payable pursuant to the sale of the Business and/or the Property, as well as to sign any document or contract for this purpose;

- ii. all the powers necessary to settle any claim including the accounts receivable and all the other claims of the Debtors, with the consent of the Petitioner where the face value of the account receivable or claim is more than \$50,000;
 - iii. all the powers necessary to open any required bank account, pursuant to the terms and conditions the Receiver may determine, with any financial institution, the whole, in order to cash any item payable to the Debtors, to initiate any transfers of funds or to issue any payment which is deemed necessary or useful to the Debtors' Business by the Receiver;
 - iv. all the powers necessary to control the cash, receipts and disbursements of the Debtors on a distinct and/or a consolidated basis for some or all of the Debtors, as applicable and as the Receiver may determine appropriate, necessary or useful, in its sole discretion;
 - v. all the powers necessary to enter into payment arrangements or agreements with any client, supplier, business party or any party contracting with the Debtors in the course of their Business which, in the Receiver's opinion, are appropriate, necessary or useful to continue and maintain, in whole or in part, the Debtors' operations;
 - vi. give directions from time to time with respect to the Accounts and the funds credited to or deposited therein, including transferring funds credited to or deposited in any other account as the Receiver may direct.
- (j) all of the powers necessary to disclaim or resiliate, any of the Debtors agreements, contracts or arrangements of any nature whatsoever;
- (k) all of the powers necessary to exercise such shareholder or member rights, including voting rights, as may be available to the Debtors;
- (l) all of the powers necessary to execute, assign, issue, endorse documents of whatever nature in respect of any of the Property, whether in the Receiver's name or in the name and on behalf of any of the Debtors (including without limitation, financial statements, tax returns and tax filings);
- (m) all of the powers necessary to exercise any rights which the Debtors may have;
- (n) all of the powers necessary to file a notice of intention to make a proposal or to make an assignment in bankruptcy under the BIA with respect to any of the Debtors and to act as a trustee for any such notice of intention or assignment, in the event that, in the opinion of the Receiver, the circumstances justify it;

- (o) all the powers necessary to bring and institute any other proceedings the Receiver deems appropriate in the performance of its duties, including for the purpose of Sections 34 and 249 of the BIA and, with the consent of the Petitioner (i) proceedings against third parties and (ii) any motion seeking the issuance of an approval and vesting order; and
- (p) all of the powers necessary to perform such other duties or take any steps reasonably incidental to the exercise of such powers and obligations conferred upon the Receiver by this Order or any Order of this Court.

[10] **AUTHORIZES** the Receiver to retain the services of any professionals, consultants, appraisers, agents, experts, auditors, accountants, managers, counsel, agent or of any person or business in order to appropriately fulfil its functions and duties, and to terminate any mandate or contract of this nature, including to retain the services of a commercial real estate broker to conduct the sale of the Debtors' immovable.

[11] **DECLARES** that the Receiver may provide creditors and other relevant stakeholders with information in response to requests made by them in writing. A copy of such requests must be sent to the Receiver's counsel. Where the Receiver has been advised by the Petitioner that information is confidential, proprietary or competitive, the Receiver shall not provide such information to any person without the consent of the Petitioner unless otherwise directed by this Court.

Debtors' Duties

[12] **ORDERS** the Debtors, their directors, officers, employees, agents and representatives to provide the Receiver, without delay, access to the Property, to the places of business and to the premises of the Debtors, as well as to the Debtors' Records and Accounts;

[13] **ORDERS** the Debtors, their directors, officers, employees, agents and representatives and any third party to preserve the Records and to refrain from destroying any information or documents or correspondence, in any form whatsoever, relating to the activities of the Debtors or to the Property.

[14] **ORDERS** the Debtors, their directors, officers, employees, agents and representatives to cooperate with the Receiver in the exercise of the powers that are granted pursuant to the terms of the Order;

[15] **ORDERS** the Debtors, their directors, officers, employees, agents and representatives not to dispose, alienate, encumber or otherwise transact in any manner whatsoever, with regard to the Property, other than in the ordinary course of business or with the authorization of the Receiver;

[16] **ORDERS** the directors and officers of the Debtors, until further order of the Court, not to communicate with, or solicit, in any manner whatsoever, the customers and employees of the Debtors, unless they have received prior written authorization from the Receiver;

Non-interference with the Receiver, the Debtors and the Debtors' Property

[17] **ORDERS** that, until further order of the Court (the "**Stay Period**"), no proceedings or enforcement measures before any court or tribunal (collectively, the "**Proceedings**") may be commenced or continued against or in respect of the Debtors, or affecting the business and commercial activities of the Debtors (the "**Business**") or the Property, except with the permission of the Court. All Proceedings already commenced against the Debtors or affecting the Business or the Property are suspended until such time as the Court authorizes their continuation, if any, all subject to the provisions of the BIA;

[18] **ORDERS** that during the Stay Period and subject to, among other things, the BIA, any right or legal action (including any right of termination, claim, right of set-off or compensation between mutual claims arising respectively prior to and on or after the date of this Order, seizures, right to distrain, executions, writs of seizure or execution, judicial or extrajudicial right of resolution or resiliation) of any individual, person, firm, corporation, partnership, limited liability company, trust, joint venture, association, organization, government agency or agency, or any other entity (collectively, the "**Persons**" and, individually, the "**Person**") against or in respect of the Debtors or that has an impact on the Business, the Property or any part of the Business or the Property, is hereby stayed and suspended unless permission is granted by the Court;

Continuation of Services

[19] **ORDERS** that any Person having an oral or written agreement with the Debtors, as well as any supplier of goods or services to the Debtors, is hereby restrained until further order of this Court from discontinuing, failing to honour, failing to renew per the same terms and conditions, altering, interfering with, terminating the supply or, where the case may be, interrupting, delaying or stopping the transit of such goods or services, as may be required by the Receiver and that the Receiver shall be authorized to continue use of the Debtors' current premises, telephone numbers, facsimile numbers, internet addresses, domain names and other services, provided in each case that the normal prices or charges (in accordance with past practices, agreements (written or oral) or contracts (written or oral)) for all such goods or services received after the date of this Order are paid by the Receiver, in accordance with the normal payment practices of the Debtors or such other practices as may be agreed upon by the supplier or service provider and the Receiver, or as may be ordered by this Court;

[20] **ORDERS** that no person shall discontinue, fail to honour, fail to renew per the same terms and conditions, alter, interfere with, repudiate, resiliate, terminate or cease to perform any right, renewal right, contract, agreement, licence or permit in favour of or held by the Debtors except with the written consent of the Receiver, or with leave of this Court;

Employees and KERP

[21] **APPROVES** the key-employee retention plan, Exhibit R-46, and **DECLARES** that all of the Property is hereby subject to a charge and security for an aggregate amount of \$1,150,000 ("**KERP Charge**") as security for all obligations of the Debtors pursuant to the KERP. The KERP Charge shall have the priority established by paragraphs [35] and [36] of this Order.

[22] **DECLARES** that the Receiver shall not be liable for any employee related liabilities, including in respect of any applicable collective bargaining agreement, or in respect of any successor-employer liabilities as provided for in sections 14.06(1.2) of the BIA other than such amounts as the Receiver may specifically agree in writing to pay, or in respect of its obligations under sections 81.4(5) and 81.6(3) of the BIA or under the *Wage Earner Protection Program Act*.

Liquidation

[23] **ORDERS** and **DECLARES** that the Receiver is authorized to sell the Debtors' movable or personal Property (including all inventory, raw materials, and equipment) (the "**Liquidation Sale**") free and clear of all security, prior claims, hypothecs, liens, claims, encumbrances, security interests, mortgages, charges, trusts, deemed trusts, executions, levies, taxes, obligations, liabilities, financial, monetary or other claims, whether or not such claims have attached or been registered, published, perfected or filed and whether secured, unsecured, quantified or unquantified, contingent or otherwise, whensoever and howsoever arising, and whether such claims arose or came into existence prior to the date of this Order or came into existence following the date of this Order (in each case, whether contractual, statutory, arising by operation of law or otherwise) (all of the foregoing, collectively, "**Claims**"), including, without limitation (a) the Administration Charge, the KERP Charge, the Interim Lender Charge, and any other charges hereafter granted by the Court in these proceedings, and (b) all Claims evidenced by registrations pursuant to the Register of Personal and Movable Real Rights (Quebec), or any other personal or movable property registration system (all of the foregoing, collectively "**Encumbrances**"), and for greater certainty, **ORDERS** that all of the Encumbrances affecting or relating to the movable or personal Property be expunged and discharged as against the movable Property, in each case effective as of the sale of the movable Property, which Encumbrances will attach instead to the proceeds of sale of the movable or personal Property, in the same order and priority as they existed as of the date hereof.

[24] **ORDERS** and **DECLARES** that the Liquidation Sale be conducted on an "as is, where is" basis, without any representation, warranty or condition of any kind, whether express or implied, statutory or otherwise, and that no purchaser shall have any recourse, claim, right of action or remedy of any kind whatsoever against the Receiver, whether in its capacity as court-appointed Receiver or in any other capacity, in connection with or arising out of the Liquidation Sale or any assets sold pursuant thereto, including any claim based on title, description, fitness for a particular purpose, merchantability, condition, quantity,

quality, existence of latent defects, and all conditions, warranties or representations expressed or implied are hereby excluded, and the legal warranty provided for by article 1716 of the *Civil Code of Québec* shall not apply to the Liquidation Sale.

Protection of Personal Information

[25] **DECLARES** that pursuant to clause 7(3)(c) of the *Canada Personal Information Protection and Electronic Documents Act*, S.C. 2000, c.5, and to comparable provisions of any provincial legislation, the Receiver may disclose personal information on identifiable individuals, which information it has in its possession or under its responsibility, to interested parties or to investors, financiers, prospective purchasers or potential strategic partners, as well as to their advisors, but only to the extent that is appropriate or required, and only upon condition that the persons to whom such personal information is disclosed shall undertake to maintain and protect the privacy of such information and limit the use of such information pursuant to confidentiality agreements entered into with the Receiver.

Receiver

[26] **DECLARES** that the powers of the Receiver shall be exercised pursuant to its sole discretion and judgment, and in consultation with the Petitioner, and that the Receiver is released from any liability or obligation in connection with his appointment and the execution of his powers, with the exception of any liability or obligation arising from his gross negligence or wilful misconduct.

[27] **DECLARES** that the Receiver may not be held liable for the payment of debts and obligations contracted by the Debtors or imposed by law, unless the Receiver undertakes to do so in writing.

[28] **DECLARES** that the Receiver is not, nor is deemed to be, an employer or successor employer of the Debtors' employees, or an employer related to the Debtors within the meaning of any federal, provincial or municipal legislation governing employment, labour relations, pay equity employment equity, human rights, health and safety or pension benefits or any other statute, regulation or other rule of law or equity for all similar purposes and, further, that the Receiver does not occupy and does not have possession, charge, direction or control of the Property or the business and finances of the Debtors, nor is deemed to occupy or have possession, charge, direction or control of the Property or the business and finances of the Debtors, within the meaning of any federal, provincial or municipal statute, regulation or rule of law or equity imposing liability on the Receiver, or municipal law, regulation or rule at law or in equity, including the *Environment Quality Act* (Quebec), the *Canadian Environmental Protection Act (1999)* or the *Act respecting occupational health and safety* (Quebec) or other similar federal or provincial legislation, and **DECLARES** that the Receiver will benefit fully from the protection of section 14.06 of the BIA.

[29] **DECLARES** that section 215 of the BIA applies *mutatis mutandis*, and hence that no action lies against the Receiver by reason of its appointment or the execution of the

powers granted by the Court, except by leave of the Court and with at least five (5) business days' notice to the Receiver and his counsel. The entities related to the Receiver or belonging to the same group as the Receiver shall benefit from the same protection afforded to the Receiver under the BIA and this order.

Interim Financing

[30] **ORDERS** that the Receiver, for and on behalf of the Debtors, be and is hereby authorized to borrow, repay and reborrow from Fédération des caisses Desjardins du Québec, Bank of Montreal, Bank of Nova Scotia, National Bank of Canada and The Toronto-Dominion Bank (collectively, in that capacity, the "**Interim Lender**") such amounts from time to time as Receiver may consider necessary or desirable, up to a maximum principal amount of USD 4,000,000 outstanding at any time, on the terms and conditions as set forth in the Interim Financing Term Sheet dated April 30, 2026, Exhibit R-2A (the "**Interim Financing Loan Agreement**") and in the Interim Financing Documents (as defined hereinafter), to fund the ongoing expenditures of the Debtors and to pay such other amounts as are permitted by the terms of the Order and the Interim Financing Documents (as defined hereinafter) (the "**Interim Facility**").

[31] **ORDERS** that the Receiver, for and on behalf of the Debtors, is hereby authorized to execute and deliver such credit agreements, security documents and other definitive documents (collectively the "**Interim Financing Documents**") as may be required by the Interim Lender in connection with the Interim Facility and the Interim Financing Loan Agreement, and the Receiver is hereby authorized to perform all of its obligations under the Interim Financing Documents.

[32] **ORDERS** that the Receiver, for and on behalf of the Debtors, shall pay to the Interim Lender, when due, all amounts owing (including principal, interest, fees and expenses, including without limitation, all reasonable fees and disbursements of counsel and all other reasonably required advisers to or agents of the Interim Lender on a full indemnity basis (the "**Interim Lender Expenses**") under the Interim Financing Documents and shall perform all of its other obligations to the Interim Lender pursuant to the Interim Financing Loan Agreement, the Interim Financing Documents and the Order.

[33] **DECLARES** that all of the Property is hereby subject to a charge and security for an aggregate amount of \$7,700,000 ("**Interim Lender Charge**") in favour of the Interim Lender as security for all obligations of the Debtors to the Interim Lender with respect to all amounts owing (including principal, interest and the Interim Lender Expenses) under or in connection with the Interim Financing Loan Agreement and the Interim Financing Documents. The Interim Lender Charge shall have the priority established by paragraphs [35] and [36] of this Order.

Administration Charge

[34] **DECLARES** that the Receiver, its Canadian legal counsel (Osler, Hoskin & Harcourt LLP) and its United States legal counsel (McDonald Hopkins LLC), counsel to the

Petitioner (McCarthy Tétrault LLP), and counsel to the Debtors (Canadian counsel Fasken Martineau DuMoulin LLP and United States counsel Foley & Lardner LLP), as security for their professional fees and disbursements incurred directly in relation to the current proceedings, both before and after the date of this Order, shall be entitled to the benefit of, and are hereby granted a charge and security over the Debtors' Property to the extent of the aggregate amount of \$700,000 (the "**Administration Charge**"), having the priority established in this Order. The Administration Charge shall have the priority established by paragraphs [35] and [36] of this Order.

Receivership Charges

[35] **DECLARES** that the priorities of the Administration Charge, the Interim Lender Charge and the KERP Charge (collectively, the "**Receivership Charges**"), as between them with respect to any Property to which they apply, shall be as follows:

- a) first, the Administration Charge;
- b) second, the Interim Lender Charge; and
- c) third, the KERP Charge.

[36] **DECLARES** that each of the Receivership Charges shall rank in priority to any and all Encumbrances affecting the Property charged by such Encumbrances.

[37] **ORDERS** that, except as otherwise expressly provided for herein, the Debtors shall not grant any Encumbrances in or against any Property that rank in priority to, or *pari passu* with, any of the Receivership Charges unless the Debtors obtains the prior written consent of the Receiver and of the Petitioner, or the prior approval of the Court.

[38] **DECLARES** that each of the Receivership Charges shall attach to the Property notwithstanding any requirement for the consent of any party to any such charge or to comply with any condition precedent.

[39] **DECLARES** that the Receivership Charges and the rights and remedies of the beneficiaries of such Charges, as applicable, shall be valid and enforceable and shall not otherwise be limited or impaired in any way by: (i) these proceedings and the declaration of insolvency made herein; (ii) any petition for a bankruptcy order filed pursuant to the BIA in respect of the Debtors or any bankruptcy order made pursuant to any such petition or any assignment in bankruptcy made or deemed to be made in respect of the Debtors; or (iii) any negative covenants, prohibitions or other similar provisions with respect to borrowings, incurring debt or the creation of Encumbrances, contained in any agreement, lease, sub-lease, offer to lease or other arrangement which binds the Debtors (a "**Third Party Agreement**"), and notwithstanding any provision to the contrary in any Third Party Agreement:

- 12 -

- a) the creation of any of the Receivership Charges shall not create or be deemed to constitute a breach by any of the Debtors of any Third Party Agreement to which they are a party; and
- b) any of the beneficiaries of the Receivership Charges shall not have liability to any Person whatsoever as a result of any breach of any Third Party Agreement caused by or resulting from the creation of the Receivership Charges.

[40] **DECLARES** that notwithstanding: (i) this proceeding and any declaration of insolvency made herein; (ii) any application for a bankruptcy order issued under the BIA or any application for a receivership order filed against the Debtors pursuant to the BIA and any receivership order granting such a request or any assignment of property affecting the Debtors that is made or deemed to have been made, and (iii) any federal or provincial law, payments or dispositions of property made by the Debtors pursuant to the provisions of this order and the granting of the Receivership Charges shall not constitute and shall not be deemed to constitute any settlement, fraudulent preference, fraudulent transfer, undervalued transaction, preferential payment or other voidable or revocable transaction or act giving rise to a remedy for abuse under any applicable law;

[41] **DECLARES** that the Receivership Charges are valid and enforceable against all Property of the Debtors and any Person;

Distributions

[42] **AUTHORIZES** the Receiver to distribute any sum of money held by the Debtors and any proceeds of the Property (including as a result of implementation of the Liquidation Sale), in its sole discretion, to:

- a) first, the Interim Lender, in reimbursement of all amounts owing (including principal, interest and the Interim Lender Expenses) under or in connection with the Interim Financing Loan Agreement and the Interim Financing Documents provided that sufficient funds are available for the payment and discharge in full of the fees, disbursements and expenses reasonably required to complete the present proceedings; and
- b) second, the Lenders, in reimbursement of all amounts owing under or in connection with the Third Amended and Restated Credit Agreement dated as of August 26, 2024, provided that sufficient funds are available for the payment and discharge in full of: (i) the obligations of the Debtors under the KERP, (ii) fees, disbursements and expenses reasonably required to complete the present proceedings, and (iii) the obligations secured pursuant to Section 81.4 of the BIA.

General

[43] **DECLARES** that the Receiver shall have the liberty to serve any notice, circular or any other document in connection with these proceedings by forwarding copies by prepaid

ordinary mail, courier, personal delivery or electronic transmission to Persons or other appropriate parties at their respective given address as last shown in the Records; the documents served in this manner shall be deemed to be received on the date of delivery if by personal delivery or electronic transmission, on the following business day if delivered by courier, or three (3) business days after mailing if delivered by ordinary mail.

[44] **DECLARES** that any party interested in these proceedings may serve any court material in these proceedings by emailing a PDF or other electronic copy of such materials to counsels' email addresses.

[45] **DECLARES** that, unless otherwise provided herein, ordered by this Court, or provided by the BIA, no document, order or other material need be served on any Person in respect of these proceedings, unless such Person has served a notice of appearance, answer or statement of representation on counsel to the Debtors, the Petitioner and the Receiver, and has filed such notice with the Court.

[46] **DECLARES** that any interested Person may apply to this Court to vary or rescind the Order or seek other relief upon five (5) business days' notice to the Receiver, the Petitioner and the Debtors, and any other party likely to be affected by the order sought or upon such other notice, if any, as this Court may order.

[47] **ORDERS** that the Receiver may, from time to time, apply to this Court for directions in the exercise of his powers.

[48] **DECLARES** that the present Order and all other orders in these proceedings shall have full force and effect in all provinces and territories in Canada.

[49] **DISPENSE** the Receiver, the Debtors and the Petitioner from providing any bond or other security.

[50] **ORDERS** that the Receiver (PricewaterhouseCoopers Inc.) is hereby authorized and empowered, but not required, to act as foreign representative (in such capacity, the "**Foreign Representative**") in respect of the within proceedings for the purpose of having these proceedings recognized and approved in a jurisdiction outside of Canada.

[51] **ORDERS** that the Foreign Representative is hereby authorized to apply for foreign recognition and approval of these proceedings in the United States pursuant to chapter 15 of title 11 of the United States Code, 11 U.S.C. §§ 101-1532.

[52] **DECLARES** that the Receiver shall be authorized to apply as it may consider necessary or desirable, with or without notice, to any other court or administrative body, whether in Canada, the United States of America or elsewhere, for orders which aid and complement the Order and any subsequent orders of this Court.

[53] **DECLARES** that that, for the purposes of any applications authorized by paragraphs [50] to [52], Debtors' centre of main interest is located in the province of Québec, Canada.

[54] **ORDERS** that Exhibits R-42 to R-46 to the Motion and Schedule A to the Report of the Proposed Receiver dated April 30, 2026 shall be filed under seal and kept confidential until further order of this Court.

[55] **REQUESTS** the aid and recognition of any Court or administrative body in any Province or Territory of Canada and any Canadian federal court or administrative body and any federal or state court or administrative body in the United States of America and any court or administrative body elsewhere, to act in aid of and to be complementary to this Court in carrying out the terms of the Order.

[56] **ORDERS** the provisional execution of the present Order notwithstanding any appeal and without the requirement to provide any security or provision for costs whatsoever.


